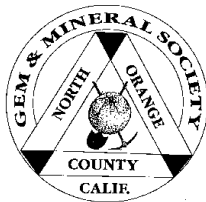

## Knapping

Knapping was the method used by Native Americans and other cultures to make arrowheads, spear points, knives, hide scrapers and other tools for millennia before the arrival of Europeans on this continent.

The heat treating method used by Native Americans was to dig a large hole in the area where knapping material was found, and then to build a fire in the hole to dry out the surrounding earth. When the fire burned down to smoldering coals and ashes, they would fill the hole with sand and the chert, flint, and any other material they wanted to knap. Then they would build a fire on top of the fill material and keep it hot for a few days, then let it die down. After the fill was cool enough, they would dig it out and start knapping their tools and weapons. Roughing out the blanks on the spot would greatly reduce the burden they would have to carry back to their home places.

Modern knappers use kilns to achieve the same effect. The kiln is loaded with material, the temperature is brought up no faster than 50 degrees F per hour, and the rocks are kept hot in the kiln for three days. They are slowly cooled down before removing them. A copper alloy is used by modern knappers for flaking because it is very close to the hardness of the antlers, horns and bones used by Native Americans.

## Field Trip Report

WGMS Club Claim

November 3-4, 2007

The annual field trip to the Whittier Gem & Mineral Society's Honey Onyx Claim is one of the most popular and well-attended trips we go on during the year. It is close to home, 4-wheel drive vehicles typically are not needed, and there is a motel just a mile from the claim which a number of NOC members take advantage of.

I arrived on Friday and installed a combination lock on the gate at the entrance to the claim area. This property is mostly under claim by Brubaker-Mann, a gravel operation. They installed the gate and keep it locked for two main reasons. First off, people were bringing their trash and garbage and dumping it along the road inside the mine property. This by itself was not very nice but it got really ugly when the BLM came in and fined Brubaker-Mann for littering (the BLM administers all of this area). The other reason is that occasionally no-goodniks enter the property and steal batteries, etc. from or vandalize the earth moving machines used there. Hence, the locked gate. The evening was perfect for a campfire so the first of two spectacular fireside moments was enjoyed. This year 28 rock hounds braved the elements to join us out in the desert. (Actually, it wasn't as brave as all that - the weather was perfect all weekend long. We enjoyed bright, sunny days with daytime temperatures maybe pushing 80° F and nighttime temps dropping to around 50° F - perfect for rock hunting and camping.)

We started out at the honey onyx mine. The mine is a little weather beaten these days and needs some serious overburden removal to expose more of the golden-yellow seams of onyx. The gem material is solidly encased in limestone and requires considerable energy and motivation to extract. Last year, a couple of people brought out the sledgehammers and heavy tools and attacked the exposed seams. This year, no one had the inclination toward hard-rock mining. So we headed off to the red moss area, a mile or so away. This is a small but productive location with high

quality moss/sagenite agate available to the determined collector. The problem for most "newbie" rock hounds is that you cannot always spot a good rock by its looking at its outside ("can't tell a book by its cover" - get it - I paraphrased... oh well, anyway...). So the field trip leader provided an example of this phenomenon. A rock collected the week before from this location had been polished on one side, thus displaying the gorgeous colors and inclusions of both sagenite and moss on the inside, and the other side left natural and as found - rough looking and unappealing. As always, teaching new rock enthusiasts our hobby is a hands-on experience and those who were interested found agate.

One of my favorite locations, the Paul Bunyan Agate Mine was next on the agenda. Here, the collecting is either in the tailings with minimal effort required or attacking the main seam in the trench with medium-heavy tools. I led the "tailings contingent" while Paul Wendling (Pasadena Club) led the assault on the exposed seam. Both groups collected agate (ask Loretta to show you her PB agate I polished for her and Don). Just around the corner from Paul Bunyan is another moss agate location, which can occasionally produce some spectacular lapidary cutting material. Mostly small stuff was found on this day, though. This location, as is true for many of the local spots, needs a couple of good pounding rains to expose new agate.

Returning to camp, a consensus of opinion was that, rather than an outdoor potluck dinner, we should instead adjourn to Peggy Sue's Diner, a local favorite eatery, which we did (saved on pot cleanup, that's for sure.) Afterwards, the campers and a few of the motel denizens returned to camp at the WGMS Club Claim and enjoyed a first-class campfire, the last of the weekend (we ran out of wood!)

Sunday morning, Dave Kely (Pasadena & WGMS Field Trip Leader) led us to two locations on the eastern side of the Calico Mountains where rock was collected by all who were collecting. At least one participant was more into taking pictures than collecting rocks, which is cool - I try to do both but it is usually necessary to concentrate on one or the other in order to be successful at either. Most of the remaining 'hounds left by around 2:00 P.M. to beat the traffic. Paul & Julie Wendling and I decided to stay until Monday before breaking camp.

Monday morning, the three remaining field trippers (Paul, Julie & I) tried to get to a mine we could see across the freeway from camp. It turned out to be *very interesting* (but schtupid...sorry - must be thinking of "Laugh In" again). We parked behind a small mountain and climbed to the top looking for way to get to the mine area. Turned out it was below us on the OTHER SIDE of the hill. And it had a road going straight to it, painfully obvious to us from our

high and very scenic overlook. As we were by now running out of time, we did a quick explore inside and outside of the fairly extensive mine complex. We found several tunnels for future exploration and a few bats to try to photograph on a return visit.

So that is how the field trip went. A number of our favorite field trippers were absent (you know who you are) but we still had a great time on the perfect weekend.
